THE REQUIREMENTS FOR REGISTRATION WITH THE ZIMBABWE REVENUE AUTHORITY

All businesses engaging in **Trade** are required to register with the Zimbabwe Revenue Authority (ZIMRA) in terms of Section 25A of **Income Tax Act; Chapter 23:06.** In terms of this section, a registrable taxpayer is defined as a person carrying on any trade or a person who has registered a company, trust, pension fund or other juristic person. The following documents are required for registration with ZIMRA and should be uploaded and submitted online - on our e-services platform. Alternatively, the documents can be manually submitted to the nearest ZIMRA office where the business is operating.
