



PUBLIC NOTICE: DELIVERY OF FISCAL DEVICES BY APPROVED SUPPLIERS AFTER PURCHASE

Zimbabwe Revenue Authority (ZIMRA) wishes to advise valued clients who are registered for **Value Added Tax**, with outstanding obligations to comply with fiscalisation requirements, that:

1. Approved Suppliers are mandated to **deliver, install and interface** fiscal devices soon after purchase within fourteen (14) days.
2. The Commissioner **shall not consider or be associated with** any commitment letters or correspondences by the Approved Suppliers purporting to have deferred delivery/installation of fiscal devices to a futuristic date after purchase/deposit by taxpayers as part of compliance to fiscalisation requirements.
3. Taxpayers should ensure that they are issued/delivered with correctly configured/interfaced fiscal devices soon after making a purchase from any of the selected Approved Suppliers within **fourteen (14) days** from the date of purchase.
4. Taxpayers are hereby advised to make purchase of fiscal devices after they have received **confirmation of availability of the fiscal device in stock** from the selected Approved Supplier.

Please Note – Full compliance with the requirement to fiscalisation entails **installation of fiscal devices on every point of sale**, which are configured to record multicurrency transactions, and **interfaced** with ZIMRA servers in real-time. Where clients have devices that cannot be configured for multicurrency, different fiscal devices should be configured to record local currency and foreign currency separately.
