May you please advise if the proof of purchase receipt is still required given that we downloaded the bidding documents from your website www.zimra.co.zw?

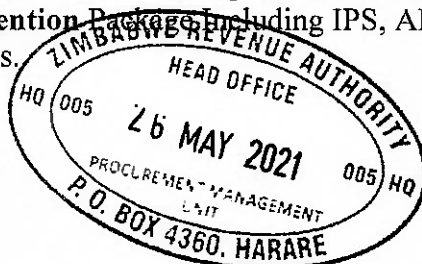
Response: No payment is to be made for bidding documents obtained online; therefore no proof of payment is required

Question 2. Service SKU – CPEBP-NGTP (Page 11 and 12)

The Service SKU indicated CPEBP-NGTP is not matching the service description given- “Enterprise Based Protection - Next Generation Threat Extraction Package Including IPS, APCL, URLF, AV, ABOT, ASPM blades”. The service description for CPEBP-NGTP should read “Enterprise Based Protection Next Generation Threat Prevention Package Including IPS, APCL, URLF, AV, ABOT, ASPM blades”.

Kindly confirm which of the following of the two is required:

- (i) **CPEBP-NGTP - Enterprise Based Protection Next Generation Threat Prevention Package Including IPS, APCL, URLF, AV, ABOT, ASPM blades.**

- (ii) **CPEBP-NGTX - Enterprise Based Protection - Next Generation Threat Extraction Package** Including IPS, APCL, URLF, AV, ABOT, ASPM, TX and TE blades.

Response: Not required as per ITT Technical Specifications


