1.	Can you provide an original (computer-readable) version of the document, so that the information can be reused correctly when preparing the bid, and re-typing the information could be avoided? We'd like to point out that Section 9.3, part 9 of the Terms of Reference (page 58 of the ITT document in PDF format) is supposed to contain an attachment (section 20 Tax Invoices.docs), however the attachment is not accessible in the provided document version.	We are able to provide to those who request it on email and we have also attached it as an addendum.

3. Please advise whether ZIMRA is seeking for a ready-made solution, or whether ZIMRA is looking for a solution provider who will build the solution for ZIMRA. Most of the requirements provided in the bidding documents (e.g., page 6) indicate intention to develop the solution for the best suitability for the ZIMRA's needs.

ZIMRA is looking for a solution that meets its requirements as per the specification. If the bidders solution meets these that is the ideal, however if there are gaps in their current solution the bidder can specify the time required to customise their solution to meet ZIMRAs requirements.

4. The bidding document and Terms of Reference state that "the Solution provider is expected to ... recommend hardware and network suitable for optimal performance of the system." However, Part 2: Statement of Requirements, page 31, provides detailed technical specification and compliance sheet for the hardware equipment of the solution. Are the hardware components sought as part of the procurement, and thus the solution must operate using the hardware provided, or is the provider requested to recommend hardware and network equipment and thus such equipment will be purchased by ZIMRA to enable the system to operate?

The bidder must use the specified equipment/hardware as a baseline and can recommend any additional hardware required for optimal performance of their solution. The hardware must be part of the solution to be delivered. ZIMRA is looking for a turnkey solution.

The Bidding Procedures (page 8) specify, that "responses to questions/queries will be made in writing to all prospective bidders at least 5 days before tender closing.". Furthermore, the "Bids must be submitted in writing in a sealed envelope to the address below..."

The tender closing period is extended to 17 May 2022.

We would like to draw the attention to the fact that the timeframe for the Bidders to reflect the responses by ZIMRA in the final proposals is extremely short, and for the bid delivery by foreign companies the timeframe provided may be too short for delivery of the bid by hand or via a courier service, whereas such delivery timeframe is impacted by the travel restrictions and unfavorable schedules as a result of ongoing COVID-19 pandemic. Therefore we ask the Procuring Entity to:

- Extend the bid submission deadline by allowing longer period between final responses to the questions and submissions of the bid
- ii) Allow for bid submission via electronic means, e.g. via email, whereas the bid would be submitted in a password-protected format, and the password will be submitted to the Procuring Entity in a separate communication (but in any even prior to the bid submission time).
- iii) Allow to submit additional questions related to the responses provided by ZIMRA, if any.
- 6. The Part 2 Statement of Requirements, List of Goods and Price Schedule refers to 2 lots, however there is no mentioning of the lots in other sections of the document (e.g. Delivery Schedule) nor reference to the lots in the Terms of Reference. Can you confirm that there are two (2) lots indeed and whether the bid can be submitted for 1 or 2 lots indeed?

Yes, there are two lots and bidders must bid for two lots.

7. The Part 2 – Statement of Requirements, Delivery Schedule refers to the physical units and applicable INCOTERM.

We understand that this is the requirement for the hardware components and should not be applied to the software solution being sought by this tender.

Please confirm whether this understanding is correct. Should there be specific delivery schedule requirements by the

organization, please clearly state those in the Terms of Reference

ZIMRA is expecting a turnkey solution. The bidder must indicate the timeframe required for delivery of both hardware and software.
