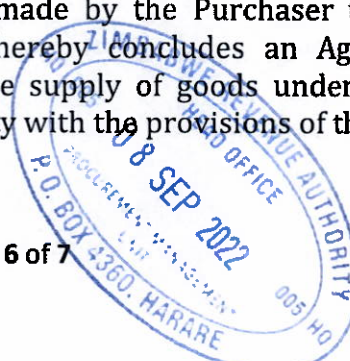
**FORM OF CONTRACT AGREEMENT**
