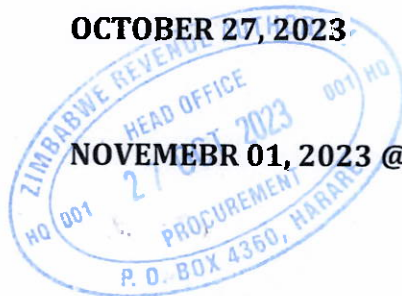

7. An order/contract will be placed with the bidder who offers the lowest price quotation.
8. Payment: 100% within 30 days of invoice date and receipt & acceptance of goods.

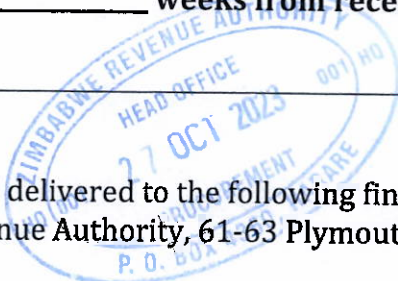
