

#### TERMS OF REFERENCE

Procurement of a Facilitator to train Zimbabwe Revenue Authority (ZIMRA) staff in PASTEL Accounting Package.

#### Background

The majority of the ZIMRA technical staff have been exposed to manual environments in terms of recorded business transactions. With technological advancements, accounting packages like PASTEL and Quick Books have been developed and are currently being used to record business transactions and generate periodic financial statements. Hard copies of ledger books, cash books etc. are now a thing of the past. Tax auditors need to understand these accounting packages which will enable them to interrogate the clients' accounts hence the need for PASTEL training.

#### **Objectives**

At the end of the course participants should be able to:

- i) Understand and gain knowledge of the accounting package.
- ii) Analyze data prepared using PASTEL accounting package.
- iii) Interrogate clients' accounts prepared using PASTEL accounting package.

#### Tasks and Responsibilities

Having regard to the objectives above the facilitator shall:-

- i) Prepare a module and other course material relating to course objectives for distribution to course participants.
- ii) Ensure that participants complete the Course Registration form.
